WHEREAS, on March 14, 2020, Amy Acton, MD, MPH, Director of the Ohio Department of Health, ordered that all school buildings that provide any kindergarten through grade twelve instruction in the State of Ohio be closed to students beginning at 12:01 a.m. on March 17 and ending at 11:59 p.m. on April 3, 2020 to prevent the spread of COVID-19 into the State of Ohio;

WHEREAS on March 30, 2020, Dr. Acton's order was extended through the end of the 2019-2020 school year;

WHEREAS the Bellefontaine City School District Board of Education and the Bellefontaine Education Association ("BEA") are subject to a collective bargaining agreement effective September 1, 2019 through August 31, 2022 ("Agreement") that provides for "reopening for financials negotiations" for the 2019-2020 school year;

WHEREAS the Bellefontaine City School District Board of Education and the Bellefontaine Education Association have expressed concern for the "uncertain circumstances" surrounding the budget cuts related to the Covid-19 Crisis:

NOW, THEREFORE, the Bellefontaine City School District Board of Education and the BEA agree as follows:

- 1. Bargaining for the "Reopening of Financials" shall be suspended for the 2020-2021 school year and shall be "reopened" for the 2021-2022 school year.
2. All bargaining unit members who are eligible for advancement shall advance 1 year on the salary schedule, but will receive a 0% increase on the base salary for the 2020-2021 school year.
3. All other benefits shall remain the same for the 2020-2021 school year.
4. This Memorandum shall become a part of and affixed to the Agreement effective with the signatures of the parties.

NOW, THEREFORE, The Bellefontaine City School District Board of Education and OAPSE Local #030 agree as follows:



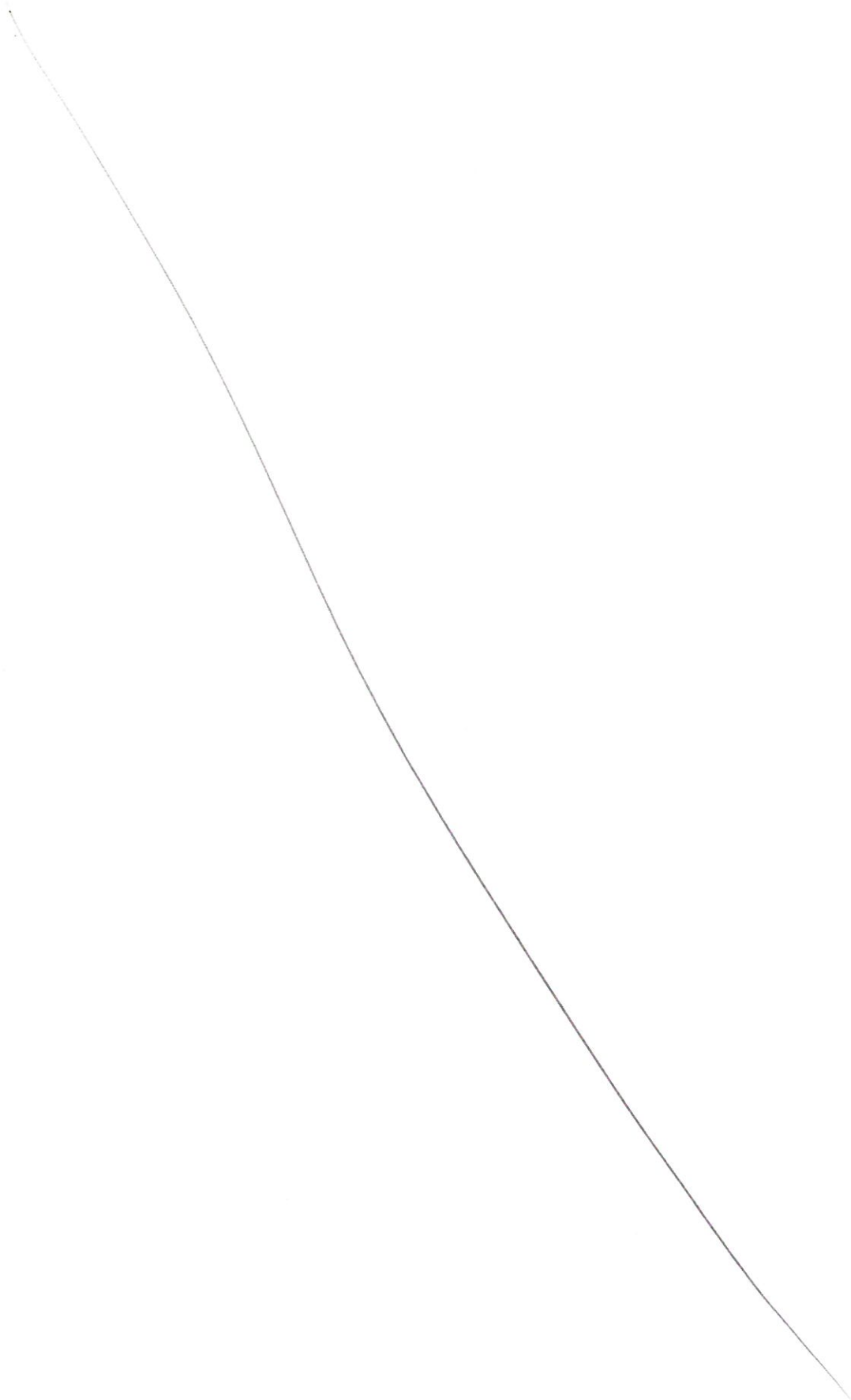
